The European Society of Oncology Pharmacy, founded in 2000 in Prague, is the largest organization of oncology pharmacists in the world with a membership of approx. 4.000 members from 66 countries. Each country has one vote in the General Assembly. The ESOP is full member of the European Cancer Organisation (ECO).

## ★ Aim and Objective

The aim of ESOP is to support optimal treatment for cancer patients. In order to achieve this aim, ESOP offers high-quality further education, guidelines and ongoing development of practices in all areas of oncology pharmacy.



## ★ Cooperation – The Oncology Team

The pharmacy as coordination center of anticancer drugs and supportive therapy implements the quality management of the oncology pharmacy service in all areas of anticancer therapy within a multi-professional team.

The centralised anticancer drug department assures high quality in every step of preparation and handling of injectable anticancer drugs while offering optimal protection of pharmacy personnel and other healthcare professionals.

The pharmacy team works in a patient-orientated way in providing pharmaceutical consultations and care. The oncology pharmacists perform activities of medication reconciliation, therapeutic education and information in collaboration with community pharmacists.

In view of the fact that financial resources have become limited, it is necessary to intensify our pharmaceutical services in order to increase cost-effectiveness, to help ensuring adequate medical treatment and to prevent quality loss.

In addition ESOP wants to make information on knowledge and achievements in cancer treatment and activities available to the public.

## ★ European Specialization in Oncology Pharmacy (EUSOP)

ESOP is proud to be able to announce the first European Certification Program for Oncology Pharmacy (EUSOP) provided by the Academy of the European Society of Oncology Pharmacy.

The 100 hour program is delivered to be accepted from the European Union for all European Countries.

After passing the whole EUSOP program, the title **“European Oncology Pharmacist (ESOP)”** will be conferred.

If you have already attended oncology trainings in your own country, there is a possibility of acceptance which will be checked and approved by the ESOP Accreditation Committee. Therefore you only have to attend the education content you have not completed in order to receive the European Title mentioned above.

The full program with a total of 100 hours contains:

- ★ Basics of Oncology Pharmacy (18 hours)
- ★ Oncology Pharmacy in practice (12 hours)
- ★ Clinical Oncology Pharmacy (45 hours)
- ★ Biologics in Oncology Pharmacy (25 hours)

The program includes 50 hours of e-learning, 12 hours of national lectures and 38 hours of national training (ExCOP - Excellence Course for Oncology Pharmacy).
